Generally speaking, all leather goods normally have a 12-month warranty from date of purchase on workmanship. Damage resulting from misuse or neglect of the product is usually not covered under their warranty. Cosmetic and appearance changes to the natural leather and fabric products are a fact of nature and again, are usually not covered under their warranty. No additional warranties apply, whether implied or other.

#### Return Policy:

If you purchased a stock saddle (any saddle that does not have a custom modification) and wish to return it, the saddle must be returned within 10 days, in perfect condition and shipped back to us, before there is a refund. A restocking fee, as much as 20% may apply, depending on the condition of that saddle.

If a saddle was ordered with custom modifications, to address your position in the seat of the saddle, and/or fit to your horse, there will not be a refund due to those modifications. However, we will make every effort to make the necessary changes, for that saddle to work for you and your horse.

If a deposit was made for a saddle with custom modifications, and that saddle order was cancelled before the delivery of that saddle, there will not be a refund for the amount of that deposit.

Used tack sold either from our on-line store, or from one of our mobile units is sold 'as is', and is non refundable.
